HISTORICAL SKETCH

In July of 1869 Adams Earl, Robert Breckenridge and Henry S. Mayo led the organization in Tippecanoe and other Indiana counties for a Lafayette, Muncie & Bloomington (Illinois) Railroad Company. In late August 1869 Tippecanoe County voted to buy \$373,000 worth of stock to help build the proposed line through Tippecanoe, Clinton, Tipton, and Benton Counties.

After many financial problems and legal battles, the Lafayette, Muncie & Bloomington was completed and connected Muncie, Indiana and Bloomington, Illinois via 195 miles of track. It operated fairly regularly during 1874–76.
