NOTES: In the course of the original processing of the Mitten collection, before the 1980s, the William Henry Harrison manuscripts were taken from it and placed in the William Henry Harrison collection. The remaining materials were organized largely according to Mitten's original scheme, though several smaller groups were merged into "American Autographs." These included: Presidents of the Continental Congress; Patrick Henry; men prominent in the Northwest Territory; Washington's cabinet; William Henry Harrison's cabinet; Zachary Taylor's cabinet; and Lincoln's cabinet. Mitten's collection also included books, pamphlets, maps, and printed, and these were placed with Printed Collections and Visual Collections at an early date.

HISTORICAL/BIOGRAPHICAL SKETCH

Arthur G. Mitten was born in Brighton, England, 13 March 1866, one of the nine children of George and Jane Lucke Mitten. In 1875 the family moved to Goodland, Indiana. Arthur had limited formal schooling. Beginning at the age of 20, he worked for the Chicago and Eastern Illinois Railroad, serving at the Swanington and Attica stations before going to the railroad's Chicago offices as an executive. He also developed considerable financial interests with his brother, Thomas E. Mitten, in Philadelphia.

By 1920 he was comfortable enough off to retire to Goodland. There he worked to develop model farms, Foster Park, and the Mitten Memorial Library given by his brother Thomas. The major interest of his last years was collecting books, pamphlets, prints, lithographs, and manuscripts on American history, centering on William Henry Harrison and the Northwest Territory. He had begun collecting in the 1890s

In 1930 Mitten was elected a vice president of Indiana Historical Society. He served in that office and on the Society's executive council until his death on 23 November 1938. He often lent parts of his collection for Society exhibits. After his death the Society purchased his collection, one of its most noteworthy acquisitions after the founding of the William Henry Smith Library.

SCOPE AND CONTENT NOTE

The Arthur G. Mitten collection includes sections on the Northwest Territory, Indiana, the War of 1812, Samuel Hodgdon, signers of the Declaration of Independence, U.S. presidents, American autographs, foreign autographs, and a miscellaneous section that includes cut signatures.

The first part of the **NORTHWEST TERRITORY** segment of the collection is a series of items arranged chronologically (box 1, folder 1). Of special interest are a letter from William Irvine to Benjamin Harrison about Indian activities (9-3-1782), a letter from Timothy Pickering to Gov. Brooke regarding the employment of scouts (1-12-1790), and a document from John Adams appointing members of the territorial Executive Council (3-4-1799). In connection with these documents, see letters of Arthur St. Clair (box 5, folder 10) and Anthony Wayne (box 5, folder 16).

This category also includes a broadside of Jefferson's plan for the Territory (box 1, folder 2) and several items regarding land surveys (box 1, folder 3).

The **INDIANA** section is important mainly as a collection of autographs: governors of the territory and state complete from 1811 to 1937 (box 1, folders 4–7); and prominent Indianians, including Schuyler Colfax, William H. English, George W. Julian, Godlove S. Orth, Daniel W. Voorhees, and William W. Wick (box 1, folders 8–16). The section concludes with items concerning Indiana state banks and the Bank of the United States in the period 1818–1850 (box 1, folder 17).

The **WAR OF 1812** section includes the papers of James Taylor, a Kentuckian who served as Quartermaster of the 8th Military District during the war. The papers span the years 1795–1847 (box 2, folders 1–4). They include Taylor's commissions in the militia as major (1800) and lieutenant colonel (1805). He eventually reached the rank of general. Beginning in 1808 he served as U.S. military agent in Newport, Kentucky. There is considerable correspondence with the Secretary of War (first Henry Dearborn, then William Eustis) concerning the provision of transport and supplies.

More than half the Taylor papers come from the period 1812–1815 when he was Quartermaster. Most are receipts (a majority for transportation and hauling); a few are more colorful, such as Chasteen Scott's description of how he whipped a rascally Yankee contractor (10-31-1814), or Joseph Kennedy's account of his progress, well lubricated with good whiskey, from fort to fort in Ohio (11-17-1814). After the war, Taylor's papers mainly concern land dealings.

A second group of papers in this section contains autographs of men prominent in the War of 1812 (box 2, folders 5–7). Most numerous among these are Secretaries of War Henry Dearborn, William Eustis, and John Armstrong; also Richard M. Johnson, who claimed to have killed Tecumseh at the Battle of the Thames and who later served as Vice President under Van Buren.

Another folder contains documents of the war chronologically arranged (box 2, folder 8), including a letter from William H. Crawford giving news of the war (10-1-1813).

Mitten's interest in William Henry Harrison led him to collect material on the Battle of Tippecanoe (box 2, folder 9). One folder on this subject traces the career of Col. John P. Boyd, a soldier of fortune who fought at Tippecanoe after

colorful adventures in India; and also contains one letter from J.H. Daveiss, a major who was killed at Tippecanoe.

In a folder on the Battle of the Thames is some correspondence of B.J. Lossing, dating from 1860–1861, dealing with the question of whether or not Tecumseh was killed in the battle (box 2, folder 10).

A folder on General William Hull's surrender of Detroit on 15 August 1812 contains bills from the owners of an ox-team lost in the surrender, from Hull for rations and provisions, and for expenses of Col. Aaron Burr as a witness at Hull's trial; also a letter from Hull to a sympathetic witness (box 2, folder 11).

A final folder traces the problems of Robert Perry in getting payment for a delayed shipment of grain to the Rapids of the Miami in 1812 (box 2, folder 12).

SAMUEL HODGDON served during the Washington and Adams administrations as quartermaster-general. In the small governmental world of the 1790s, this brought him into contact with Alexander Hamilton, Henry Knox, John M. Lovell, and Richard Henry Lee. He seems to have been intimately connected with Timothy Pickering, and the latter's letters show him having land dealings in western Pennsylvania, borrowing repeatedly from the Bank of the United States and from Hodgdon, and planning his son's future. The Hodgdon papers are arranged alphabetically by correspondent (box 2, folders 13–16).

In Mitten's arrangement, the Hodgdon papers were intermingled with letters addressed to Henry D. Gilpin (box 2, folder 17, and box 3, folders 1–2), an English native who served under President Jackson as U.S. Attorney for eastern Pennsylvania and as a government director of the second Bank of the United States, and under President Van Buren as Solicitor of the Treasury and then as Attorney-General. With the advent of the Whigs in 1841, he retired to a life of "luxurious literary ease." Letters addressed to Gilpin have been separated from the Hodgdon papers, and also arranged alphabetically by correspondent. Perhaps most interesting are a letter from Gov. Chittenden of Vermont concerning politics in his state; a letter from C.C. Harper concerning French politics in the last year before the 1830 Revolution; and letters about Washington politics from Robert T. Lytle in 1836 and someone named Roemer in 1841.

The **AUTOGRAPH COLLECTIONS** include signers of the Declaration of Independence (box 3, folders 3–6) and U.S. presidential documents and autographs from Washington to Franklin Roosevelt (BV 2579; box 3, folders 8–29; and box 4, folders 1–10).

A facsimile letter from George Washington to Arthur St. Clair warning him against using proclamations to accomplish what should be done by legislation; a letter from John Quincy Adams as Secretary of State in 1824 commenting on the intentions of the Holy Alliance just after the pronouncement of the Monroe Doctrine; a number of documents dealing with Andrew Jackson's negotiations with the southwestern Indian nations in 1816–1818; a letter from John Tyler before the 1840 Whig convention, extolling the virtues of William Henry Harrison; a letter from Millard Fillmore on why he signed the Fugitive Slave Law of 1850.

Non-presidential American autograph documents (box 4, folders 11–27, and box 5, folders 1–19) include a letter from William H. Crawford, after the stroke which removed him from the electoral race in 1824, complaining that his fingers are "clumsy"; a letter from Andrew Ellicott in Natchez in 1797, alerting a friend in Kentucky to the activities of a Mr. Powers on behalf of the Spanish government; a letter from John Randolph in 1805 urging James Monroe to step in, rather than James Madison, as President Jefferson's successor; a letter of Arthur St. Clair defending his practice as Governor of the Northwest Territory of taking a fee on marriage licenses; two letters from Anthony Wayne about military affairs in the Northwest Territory in 1791–1793; a letter from Thurlow Weed in 1879 expressing dissatisfaction with several of President Hayes's policies.

A small section of documents and autographs from outside the U.S., largely British officials of the 18th and 19th centuries, can be found in box 5, folders 20–23.

MISCELLANEOUS materials include John Sibley's journal (box 6, folder 1), covering the period 5 January to 30 December 1807, describing his work as Indian agent in the area just to the northwest of New Orleans, just after the Louisiana Purchase. He was variously occupied in hunting down murderers, giving presents, and making overtures of

friendship to Indian chiefs in an area where the U.S.-Spanish border had not yet been settled.

The report of William Clark, Ninian Edwards, and Auguste Chouteau (box 6, folder 2) describes the work of those who surveyed the territory ceded by the Osage Indians to the United States in 1808. Also involved were hearing the claims of the Cherokees and the complaints of the Massaws [?].

Box 6, folder 3, contains two letters in Aaron Burr's hand, two bills signed by his colleague Harman Blennerhassett, and two letters from T. H. Cushing, on his way from Missouri to Richmond to be a witness in Burr's trial.

Box 6, folder 4, contains two items signed by Alexander Hamilton, a note from Tobias Lear on Hamilton's behalf, and correspondence of two of Hamilton's sons. The bulk of the material is an exchange between John Church Hamilton and H.D. Gilpin as the former worked on an edition of his father's letters.

Materials related to (but not of) Andrew Jackson can be found in box 6, folder 5. Of special note in the material on the Harrison family (box 6, folder 6) are a letter from Gov. Benjamin Harrison of Virginia to the Governor of Pennsylvania regarding the surveying of the boundary between their states in 1782, and a letter from Mrs. Benjamin Harrison (Caroline Scott) giving her frank views of the 1888 Republican convention.

The folder on Slavery (box 6, folder 7) contains three items concerning the ownership of slaves. The folder on Transportation (box 6, folder 8) includes nine items concerning rail, canal, and steamboat transportation in the period 1837–1852. Finally, cut signatures can be found in box 6, folders 9–11.

Graphics materials in the collection include engravings of prominent American men of the 18th and 19th centuries, stored in the oversize graphic boxes. Photocopies of these items are stored in boxes 7–8.
