#### HISTORICAL SKETCH

**Equal Rights Amendment (ERA):** Although the Equal Rights Amendment was first introduced in Congress in 1923, both houses of Congress did not pass the ERA until 1972. When the amendment was sent out to the states with a ratification deadline of 22 March 1979, thirty states ratified within the first year. However, opposition to the amendment also began to organize and solidify, most notably from Phyllis Schlafly's Eagle Forum/STOP ERA. Eight more ratifications were needed to adopt the ERA, and because of the opposition, few trickled in.

In August 1973, Hoosiers for the Equal Rights Amendment (HERA) was established to stir up public support and lobby lawmakers to pass the amendment after the Equal Rights Amendment was not ratified by the 1973 Indiana General Assembly. The organization disbanded in 1976, as publicity and advocacy efforts were taken over by operatives for the National Organization for Women. The campaign was successful, and the ERA was ratified by the state of Indiana on 24 January 1977, bringing the count to thirty-five states. Chances of getting three more states by the deadline looked grim as conservative opposition gained more popularity. As a result, NOW and other pro-ERA groups asked Congress for an extension. Congress granted the extension until 30 June 1982 and pro-ERA groups re-focused on targeting three more states for ratification.

**Dorothy Steinmeier:** Dorothy Steinmeier was born in Indianapolis, Indiana, in 1916. She grew up on the north side of Indianapolis and graduated from Broad Ripple High School. She attended Butler University for a short time before transferring to the University of Wisconsin. There she earned a Bachelor's Degree in Journalism. Dorothy's first position out of college was at Indiana State Farm where she worked her way up to Associate Editor of the Hoosier Farmer. She worked in several other writing-related positions, including a brief stint as the Feature Writer for the U.S. Constabulary of the U.S. Army in Germany during World War II and a position at the Bookwalter Company, before finding her passion in politics. By the 1960s, Dorothy was working in Public Relations for the Indiana State Democratic Campaign Headquarters in women's affairs and then later the Indiana Democratic State Central Committee. She spent the latter half of the 1960s working as Associate Director of Information for the Indiana Department of Commerce before moving on to be the Assistant Editor for *The Indiana Teacher* from 1967–71. Throughout her life, Dorothy was a member of several writing organizations including Women in Communications, Woman's Press Club of Indiana, and National Board of the National Federation of Press Women, and Indiana's ERA organization. Dorothy passed away in 2006.

#### Series 1:
