#### **BIOGRAPHICAL SKETCH**

John Caldwell (d. 1835) operated a general store in Vincennes, Knox County, Indiana in the early 1810s, and a similar establishment in Shawneetown, Gallatin County, Illinois circa 1814–35. He was also Receiver of Public Monies at Shawneetown's U.S. land office, and operated his own legal practice. Beginning in 1824, Frederick Rapp employed Caldwell to operate his general store in Shawneetown for him. Caldwell operated Rapp's store at least through 1828.

In 1814 Caldwell married Sarah Badollet (dates unknown), with whom he had several children. They included John Badollet Caldwell (1819–68); William Lynn Caldwell, who attended the U.S. Military Academy at West Point; and Albert G. Caldwell. Sarah Badollet Caldwell managed her husband's estate after his early death in 1835.

John Badollet Caldwell was a businessman who traveled extensively, making business trips to Louisville, Cincinnati, Philadelphia, New York, and Boston. In the 1840s he married Margaret Badollet, with whom he had at least six children. Among them were Albert Gallatin Caldwell (1845–1923), not to be confused with his uncle of the same initials; Margaret Caldwell Jones; and Arthur Caldwell.

Albert Gallatin Caldwell (1845–1923) attended the U.S. Naval Academy in 1862–63. After graduation, he served on the USS *Colorado*, U.S.S. *Shamrock*, U.S.S. *Hipsic*, U.S.S. *Lancaster*, U.S.S. *Pinta*, and U.S.S. *Vandalia*. In the 1870s he was an instructor at the Naval Academy, probably 1872–76. He resigned his commission in 1884. He remained single and by 1920 was living in Indianapolis with his brother Arthur Caldwell, his sister Margaret Jones, and her husband Benjamin Jones. He died of a stroke in 1923.

### **SCOPE AND CONTENT NOTE**

Series 1 is composed solely of the microfilmed papers of the collection.

Series 2 comprises John Caldwell's business papers, including receipts, accounts, deeds, and correspondence related to his businesses in Vincennes and Shawneetown. The receipts and accounts provide a thorough picture of what items were in demand by frontier residents in the early nineteenth century. Also in this series is the contract in which he agrees to manage Frederick Rapp's general store in Shawneetown.

One of the most important papers in this series is an 1817 transfer of an indenture (a bill of sale in all but name) for a black woman named Emma. The paper records the sale of Emma's indenture by John Caldwell to John Cox. It notes that Caldwell bought her from a Kentucky resident in 1814 and brought her to Gallatin County in Illinois Territory. At the time, neither Indiana Territory nor Illinois Territory allowed enslaved people to be brought in (though those who were already there remained enslaved), and any free blacks entering had to post a prohibitively expensive bond. Thus, enslaved people could easily be forced to sign long indentures that essentially kept them enslaved for decades, if not the remainder of their lives. A significant number of enslaved and indentured African Americans lived in the Shawneetown area and worked in the local salt mines.

Series 3 is made up of miscellaneous family documents, including papers relating to the estate of John Caldwell.

Series 4 holds the family's personal correspondence and photographs. Notable are the ardently romantic letters written by John B. Caldwell to his wife Margaret B. Caldwell in the 1840s, and the letters of Albert Gallatin Caldwell (not to be confused with his uncle Albert G. Caldwell).

Also notable are several emotional notes that have been penciled onto correspondence by an "Aly C." He reserved the greatest ire for Albert G. Caldwell, about whom one note reads, "The writer was full of fine words but he was a skum [sic], a sham, deserted his mother & minor children & got married."

The letters of Albert Gallatin Caldwell comprise a large portion of Series 4, and are among the most significant materials in the collection. Sent to his mother and other family members, these cover his time at the U.S. Naval Academy and while serving aboard ships in the Mediterranean and the Americas. As a high-ranking officer, he occasionally entertained foreign and American dignitaries, including former President Ulysses S. Grant. He is confident, opinionated, and conservative. Following is an index of notable letters:
