SCOPE AND CONTENT NOTE

The addition consists of an assortment of Indiana related political letters spanning the years 1866–1907. The letters are:

- 6 August 1866–from M. C. Kerr (U.S. Representative from Indiana), New Albany, IN, asking the recipient to make speeches in Orange, Crawford, and Perry Counties.
- 2. 2 November 1888–J. S. Fassett (Secretary, Republican National Committee), New York, to William F. Stone, Baltimore, MD, confirming receipt of a check.
- 3. 17 May 1889–William W. Dudley (attorney), Washington, D.C., to Samuel Fessenden, Stamford, CT, regarding the payment of an assessment.
- 4. 17 March 1896—Charles L. Henry (Committee on Public Buildings and Grounds, U.S. House of Representatives), Washington, D.C., to George F. McCullough, Bluffton, IN, regarding the appointment of delegates.
- 5. 24 November 1897–Thomas Hanna (President, Republican Camp of Veterans and their Sons of Indiana), Indianapolis, IN, to George F. McCullough, Muncie, IN, regarding endorsing a speaker and getting votes.
- 6. 4 January 1898–Perry S. Heath (First Assistant Postmaster General), Washington, D.C., to George F. McCullough, Indianapolis, IN, regarding late receipt of a prior letter and request.
- 7. 14 February 1898–Charles S. Hernly (attorney), New Castle, IN, to George F. McCulloch, Muncie, IN, thanking him for his campaign support and notifying McCulloch of his selection as a member of the Executive Committee.
- 8. 25 July 1900–Charles S. Hernly (Chairman, Republican State Committee) Indianapolis, IN, to Geo. M. McCullough, Muncie, IN, regarding McCullough's appointment to the Finance Committee.
- 9. 8 September 1900–H. H. Hanna (Chairman, Executive Committee of the Indianapolis Monetary Convention), Indianapolis, IN, to George F. McCulloch, Muncie, IN, regarding losing control of the lower House in the upcoming election and support for the election of Geo. W. Cromer.
- 10. 25 August 1902—Winfield T. Durbin (Indiana Governor), Indianapolis, IN, to James D. Oliver, South Bend, IN, requesting Oliver's attendance at a meeting regarding prison-labor in the state.

- 11. 22 November 1904–J. A. Hemenway, Indianapolis, IN, to Jos. D. Oliver, South Bend, IN, requesting Oliver's support in his campaign for a position in the U.S. Senate.
- 12. 8 February 1907–Joseph B. Kealing (U.S. Attorney, District of Indiana), Indianapolis, IN, to Messrs. Bailey & Cole (attorneys), Peru, IN, regarding purchase of land for a post office.
