Hopewell Monthly Meeting Minutes and Marriages (Henry County)

Hopewell Monthly Meeting was set off from Milford Monthly Meeting and first held Fourth Month 17, 1841. Friends had formed “the upper settlement of Symons Creek” in Dudley Township, Henry County, as early as 1823.

The first Hopewell Meetinghouse was about three-fourths of a mile southeast of the present site. In 1850 the meetinghouse was moved to a crossroads for easier accessibility and a new graveyard begun. A few tombstones remain at the older site.

Friends began to settle in Franklin Township, Henry County, in the 1820s. In 1835 Rich Square Preparative Meeting was formed, named for Rich Square Meeting in Northampton County, North Carolina, the old home of Jeremiah Parker, who sat at the head of the meeting. When Hopewell Monthly Meeting was set off from Milford in 1841, it was composed of Hopewell and Rich Square preparatives. A third preparative meeting, at Lewisville, opened in 1888. In 2004, only Hopewell Meeting still functions.

The following records are in the Indiana Yearly Meeting Archives in the Friends Collection at Earlham College. Those indicated with an asterisk (*) were examined for this abstract.
