The Living Descendants of Robert and Mary Logan Elliott in 1908

Robert Elliott (1784–1872) and his first wife, Mary Logan (1788–1822), were married in Montgomery County, Ohio, in 1807.¹ They had seven children—the three youngest born after the family moved in 1816 to Monroe Township, Jefferson County, Indiana. Six of their children survived to maturity and had families of their own: Anthony Logan, Jane, William, Robert Jr., Martha, and James McClure.

In 1908 Robert Elliott and Mary Logan had 136 living descendents residing in twelve states and one foreign country as documented by the list below, which provides the locations of family members at that time. Although lacking attribution, this list was most likely compiled by David McClure Elliott (1849–1919), a grandson of Robert Elliott and Mary Logan, as a companion to a family history that he authored and read at a reunion held at the home of William Officer in Jefferson County, Indiana, on September 15, 1908.

Elliott had this history privately printed as a ten-page pamphlet. The pamphlet was transcribed and annotated by Ken Hixon and published as "Elliott Family History: A 1908 History of the Elliott and Related Families of Jefferson County, Indiana," in the spring/summer 2008 issue of *The Hoosier Genealogist: Connections* (which the reader should refer to for additional details and information).

The list was transcribed by Hixon from a carbon copy of the typewritten document, containing handwritten notations providing generational and kinship information. For the sake of clarity the list has been reformatted, the handwritten notations have been replaced with more easily read symbols, and a legend has been supplied. The order of the names as well as the original spellings of the names and addresses has been carefully preserved, although extraneous punctuation has been omitted. Note that the numbers following the symbols "B" and "M" in the right column refer, apparently, to the number of people in each entry who were related by blood or by marriage, respectively, to Robert and Mary Logan Elliott.

Information regarding the spouses of the children of Robert Elliott and Mary Logan and dates of birth and death for these children and their spouses has been supplied by Hixon based on his genealogical research. Hixon's annotations and alterations are in brackets: [example].

The list came into Hixon's possession following the death of his maternal grandmother, Miriam Weir Bates (1902–1997). His great-great-grandmother, Elizabeth Elliott Weir (1839– 1901), was David McClure Elliott's sister.
