NOTES:

Florence Baker Holliday (1871-1947) was born in Indianapolis, the daughter of Conrad Baker, Governor of Indiana and founder of the law firm of Baker and Daniels (See: M008, Conrad Baker Papers). She had wide cultural and philanthropic interests. She was a founder of the Dramatic Club, and a member of the Woodstock and Progressive Clubs, the Propylaeum, the Garden Club of Indianapolis, and the Marion County chapter of the Women's Organization for National Prohibition Reform. (See: M 646, Dramatic Club Records; M 699, Indianapolis Propylaeum Records; M 672, Garden Club of Indianapolis Records; and SC 1631, W.O.N.P.R. Minutes).

Her husband, Jaquelin S. Holliday (1867-1944) was born in Indianapolis, the son of William J. and Lucy (Redd) Holliday. He graduated from Racine College, and attended Yale Law School in 1887-1888. From 1900 to 1940 he was president of W. J. Holliday and Company, a wholesale iron and steel firm, and expanded its operations to include a branch in Hammond.

The Hollidays were one of the five families who built homes in Shooters Hill, an incorporated village on the bluffs above White River just east of Michigan Road.

SCOPE AND CONTENT NOTE

This collection consists of 15 diaries kept by Florence Baker Holliday. The diaries cover the years 1909 and 1930 through 1942. Many of the entries are brief, filling no more than one page, and document Mrs. Holliday's daily activities. She often mentioned her attendance at club meetings, visitors, people she dined with, and books she read. She also included various trips taken by her and her husband, Jaquelin Smith Holliday. Interesting entries include: a visit to see Booth Tarkington's play, *Colonel Satan* (7 January 1931); a visit with President Herbert Hoover while in Washington, D.C. (15 April 1931); and dinner at Meredith Nicholson's home (19 May 1931). The 1931 through 1933 diaries contain numerous references to her anti-Prohibition activities and attendance at meetings of the Marion County chapter of the Women's Organization for National Prohibition Reform.

The collection also contains a 1941 diary that does not appear to be Mrs. Holliday's; however, the author could not be identified.
