BIOGRAPHICAL SKETCH

Gregorio "Greg" Chavez Jr. (November 21, 1932-February 9, 2022) was born in Robstown, Texas to parents Gregorio Chavez Sr. and Aurora Hughes Chavez. Greg's parents were migrant farm workers in the 1930s and 1940s. Greg had four siblings, one of which being an older sibling from his mother's previous marriage. During his upbringing in Grand Rapids, Michigan, Greg attended South High in Grand Rapids and graduated in 1952. Shortly after graduation, he enlisted in the United States Air Force and completed his training in Texas. While stationed, Greg met and married his wife, Rosa Garza, in 1954. During his twenty-year military career with the Air Force, Greg was stationed in Japan, Korea, Germany, and stateside (with his family) in Roswell, New Mexico.

In 1972, Greg, Rosa, and their children relocated to South Bend, Indiana. Greg's civic engagement is first documented in 1976 at LULAC, the League of United Latin American Citizens, where he contributed to their national education efforts, the LULAC National Education Centers (LNESC), their National Scholarship Fund initiative, and as a member of his local chapter, LULAC #5001. From 1976 to 2011, Greg contributed to LULAC as the Indiana State Director (1977), Vice-President of the Midwest (1982), and State Parliamentarian (2002). He also expanded his engagement to include LULAC's employment program, SER-Jobs for Progress, and the LULAC Youth initiatives. Through his LULAC involvement, Greg partook in voter registration and political action.

In 1980, Greg and other parents in South Bend saw the need for more support systems for the Latino families moving in and advocated for the establishment of the South Bend School Corporation's Bilingual Department. That year, he was also appointed onto the South Bend Human Rights Commission and evaluated discrimination charges in areas of employment, housing, education, and social identity.

In 1987, he opened his own mill (*Chavez Molino*) with his brother, Marshall Chavez, and started his business *Original Foods, Inc.* Original Foods Inc. manufactured flour and corn tortillas for one year. After, Greg found a position in the South Bend School Corporation's bilingual department. Over the next 30 years, Greg lent his expertise to community organizations targeting Hispanic/Latino and migrant family support. Many initiatives centered around youth, education, health care, employment, housing, and entrepreneurship were established in his home county of St. Joseph.
