BIOGRAPHICAL SKETCH

Howard Christopher Baker was born 16 March 1891 in Bellaire, Ohio to Everett Baker and Lena McKeen. By 1900, the family had moved to Jackson Township in Hamilton County, Indiana. A decade later, they were living in Indianapolis, Indiana, where Baker worked as a freight office clerk. By 1918, he worked as the treasurer at O.D. Haskett Lumber Company. Baker began his military service in April 1918. He served as a private in Company L, 323rd Infantry, 81st Division. He was discharged on 28 May 1919. After the war, Baker returned to Indianapolis and his job at the lumber company. Between 1935 and 1940, he moved to Chelsea, Michigan with his wife, Marian (Mae) Baker, and his stepson, John Stone. Baker died on 29 April 1948 and was buried at Lauderdale Memorial Park in Lauderdale, Florida.
