The iPhone: A Revolutionary Invention is my selected topic because I wanted to present on a technology that was a turning point in the history of phones. Like the historic moment on March 10, 1876 when Alexander Graham Bell made the first phone call in history, Steve Jobs, on January 9, 2007, made the first phone call on the iPhone, altering how we communicate today. I chose the creation of the first iPhone because of its impact on the world and technology by completely reinventing the phone through incorporating touch screens, keyless keyboards, a camera, and access to the internet all into one device.

I found many interesting pictures and facts about the phone throughout the last century. From the original rotary landline phones, to the bulky car phones, then the first boxy wireless phones, the flip phone, the Blackberry, these were all building blocks towards the creation of the first iPhone in 2007.

One important primary source about the iPhone was the YouTube video by The Wall Street Journal called *Apple's Secret iPhone Launch Team: The Event That Began It All.* It was a key source because it contained interviews from Greg Christie, Tony Fadell, and Scott Forstall, the original design team members of the iPhone. They explained what it was like creating the device. Another useful source was the video by Protectstar Inc. called *iPhone 1 - Steve Jobs MacWorld Keynote in 2007 - Full Presentation, 80 mins.* It included the entire presentation of Jobs introducing the iPhone, which I used clips in my documentary.

I chose to create a documentary because a history on the iPhone has many primary sources including excellent photos and videos. Additionally, I was interested in learning more about video editing, and that was something unfamiliar to me. I used CapCut to create my documentary by adding online videos and photos.

My thesis statement states: The invention of the first iPhone was a turning point in not only technology, but the way we communicate, and altering the purpose and utilization of phones.

Through new features to the phone including a full screen design and touch screen technology, it was easy to call or text, read the news online, watch a movie, or listen to music.

This topic is a key turning point in history because in less than 20 years it has had significant impact on how everyone communicates. The iPhone not only changed how we think of and use the phone, but it also changed the way we live our lives.
