## **BIOGRAPHICAL SKETCH**

Jill Chambers is an activist in Indianapolis, IN. Chambers worked with a number of women's rights organizations from the 1980s to 2000s. She was extensively involved with Indiana NOW, the state branch of the National Organization for Women, as a lobbyist in the 1980s and the editor of their newsletters for two decades from 1978–1998. From 1980–82, Chambers was President of Indiana NOW and from 1985–86, she served as the Executive Director.

In addition to her work with Indiana NOW, Chambers was involved in other activist organizations in Indiana. She worked as a lobbyist for the Gender Fairness Coalition in 1989. She's been involved with the Fund for Feminist Majority, American Association for University Women, Pro-Choice Coalition/Health Access and Privacy Alliance, Hoosier Alliance for Consumer Rights, and Mothers' Advocates.

Chambers work has not solely been political activism. Beginning in 1997, Chambers was involved in preserving women's history in Indiana with the Indiana Women's History Association (IWHA). Chambers served on the IWHA board, and was Chair from 1998–2000. In 2004, she served as President of IWHA.

Chambers has also been involved in the arts in Indiana. In addition to running her own graphic design studio, Creatix, Chambers has been involved with INPrint and Hoosier Salon.

Chambers resume demonstrates the full extent of her work in activism, women's history, and the arts. This collection reflects her various activities from the 1970s to 2000s.

## **SCOPE AND CONTENT NOTE**

### **Series 1: Personal Correspondence and Papers, 1966–2003**

This series contains personal correspondence written to Jill Chambers from 1989–2000. Also included are a number of datebooks and calendars. In addition, this series contains newsletters Chambers received from a number of organizations, magazine subscriptions, and miscellaneous brochures. Also included in this series are topical folders that include materials related to a number of topics related to Chambers work.

### **Series 2: Indiana NOW, 1970–2006**

This series contains records related to Indiana NOW spanning multiple decades. Included in this series is correspondence related to Indiana NOW, files related to individual Indiana NOW branches, Indiana NOW conferences and events, and other administrative and financial documents. This series also contains materials related to lobbying and PAC activities of Indiana NOW from the 1980s to 2000s. Also included are Indiana NOW newsletters, topical files, and brochures/newsletters for related organizations.

### **Series 3: National NOW, 1980–2005**

This series contains materials related to national NOW as opposed to the state branch in Indiana. Included in this series are administrative documents, communications from NOW, NOW conference files, and newsletters.

### **Series 4: Gender Fairness Coalition, 1987–2005**

This series contains records for the Gender Fairness Coalition. Included in this series are documents related to administration, finance, and events. However, the bulk of this series consists of materials related to lobbying activities and legislative updates.

### **Series 5: The Fund for Feminist Majority / The Feminist Majority, 1990–97**

This series contains materials related to the Fund for Feminist Majority/The Feminist Majority in the 1990s. The bulk of this series pertains to the Becky Bell - Rosie Jimenez Campaign of the early 1990s.

### **Series 6: Indiana Alliance for Better Child Care, 1985–89**

This series contains materials related to Indiana Alliance for Better Child Care, ABC. Indiana ABC records contain minutes, agendas, correspondence, and clippings.

### **Series 7: American Association of University Women, 1991–2005**

This series contains materials related to the American Association of University Women (AAUW) from 1991–2005 and includes correspondence and minutes. This series primarily consists of newsletters for AAUW from the local, state, and national levels.

**Series 8: Pro-Choice Coalition / Health Access and Privacy Alliance, 1989–2005**

This series contains materials related to the Pro-Choice Coalition (later called the Health Access and Privacy Alliance), including minutes, correspondence, and information sheets.
