BIOGRAPHICAL SKETCH

Joseph and Georgia (Garrett Lane) McGuire were professional commercial photographers who documented the changing built environment of Indianapolis for half a century. After serving in the Korean War, Joe McGuire started his career at the Robert Young Studio (2911 West Washington Street), which he purchased in 1962 and later rebranded as McGuire Studio Inc. By the 1970s, Georgia Garrett Lane was employed at McGuire Studio Inc. as a sales representative and photographer. In the 1980s, the McGuire's moved the studio into their home at 3148 North Pennsylvania Street. Joe retired from MSI in 1992.

The bulk of MSI's work revolved around downtown architecture: skyline views for the tourism industry, aerial shots for city government, new building construction for contractors and developers, and extant building documentation for historic preservation projects. MSI also did portraiture and event photography for politicians, grounds and exhibit work at Conner Prairie, and some stock photography.

Materials in collection

SCOPE AND CONTENT NOTE

The majority of the collection is photographic images and negatives of the city of Indianapolis featuring the skyline, aerial photography, and individual buildings, taken by photographers Joseph and Georgia McGuire between 1950 and 2000. Joe McGuire started his career at the Robert Young Studio, which he purchased in 1962 - some of the early images in this collection are attributed to the Robert Young Studio. MSI also did portraiture and event photography for municipal and state government officials, work at Conner Prairie, and some stock photography.

Series 1 contains images of the Indianapolis skyline in chronological/job order, first daytime skyline images and then nighttime skyline images.

Series 2 contains aerial photography in chronological/job order.

Series 3 contains images of individual buildings in alphabetical order, with the date and job number listed when available.

Series 4 contains stock photography and events in chronological/job order.

Series 5 contains images of politicians and political events in chronological/job order.

Series 6 contains images of Conner Prairie grounds, artifacts, and events in chronological/job order.

Series 7 contains miscellaneous images in chronological order.
