BIOGRAPHICAL SKETCH

Mark A. Kurtz, of Goshen, Indiana, served as Airman First Class in the U.S. Air Force during the Vietnam War. He distinguished himself as Photo Interpreter, 13th Reconnaissance Technical Squadron, Tan Son Nhut Air Base, Republic of Vietnam, earning the Air Force Commendation Medal for meritorious service. Throughout his life, he has had a dual career in aviation and photography.

Mark Allen Kurtz was born on 13 June 1942 in Goshen to Ezra and Anna Grace Bollinger Kurtz, the third of their four sons. His interest in airplanes and photography began in childhood. At Goshen High School he took photographs for the student newspaper and yearbook until he graduated in 1960. In 1961 he took his first flying lesson.

Early employment opportunities for Mark included: fingerprint clerk with the FBI's Identification Division in Washington, DC; photographer apprentice at Herring Studio in Elkhart, Indiana; staff photographer-lithographer at the Church of the Brethren General Board in Elgin, Illinois, where responsibilities included photo processing, nationwide annual conference photo coverage, and creative art photography for seminars.

Mark's active duty in the U.S. Air Force was from 1963 to 1967, followed by two years of reserve duty. He served at Lackland Air Force Base (AFB) in Texas; Lowry AFB in Denver; Shaw AFB in South Carolina; Tan Son Nhut Air Base near Saigon (now officially known as Ho Chi Minh City); and Nellis AFB in Las Vegas. In Vietnam, Mark was a photo intelligence technician, with the responsibility of interpreting details in aerial photographs, radar images, and infrared images. He also taught photography classes to other airmen.

Mark was in Vietnam from November 1965 through November 1966. Most of the photographs he took there were taken with a Mamiya C-3 twin lens reflex camera, using black-and-white 120 film. He developed the film and made prints at the Base Photo Hobby Shop, where he eventually became manager. The photo darkroom conditions were less than ideal, as the heat made it difficult to manage process temperatures. He had also taken the photographs without benefit of a light meter, so all exposure calculations were estimates, resulting in inconsistencies among the photos.

In 1968, after his military service, Mark became a flight instructor at Airgo, Inc., the Fixed Base Operator (FBO) at Goshen. From 1968 to 1972, he worked as the staff photographer for *The Goshen News*. From 1972 to 1975, Mark worked at the FBOs in Goshen, Valparaiso, and Plymouth, Indiana, as flight instructor, charter pilot, and manager. From 1975 to 1979, he was FBO manager at Skystream Goshen.

In 1977, Mark married Karen B. Swartzendruber. In 1980, they established Kurtz Lens and Pen, Inc., a writing-photography business. The Kurtz Team specialized in portraiture, aerial, editorial, and commercial photography. Karen left teaching to work full-time in the business while Mark continued his full-time aviation career. The Kurtz Team, which still exists as of 2025, has written and published articles for readers of all ages in books and magazines, as well as for businesses, advertising, and publicity. Mark's aviation experience led to publishing articles and photographs on that topic in various regional and national magazines.

Mark was the pilot for Goshen Rubber Company, Inc., from 1979 to 2000. He earned his Airline Transport Pilot certificate.

Mark was an active member of the Goshen Aero Club, serving as an officer and producing the club's monthly newsletter. He was appointed general manager and president of Airport Celebration '88, Inc., a committee that implemented Goshen Airport's fiftieth anniversary celebration.

From 2000 to 2003, Mark flew with Raytheon Travel Aire, and after that company's merger with Flight Options, LLC, he continued flying with that company until his retirement on 30 July 2005. Throughout a forty-year aviation career, Mark flew a total of 13,251.6 hours and an estimated 2,438,592 miles.

SCOPE AND CONTENT NOTE

This collection contains a variety of materials pertaining to Mark A. Kurtz's time in Vietnam in 1965–1966 while in the Air Force but consists primarily of photographs he took there. The photographs depict the Tan Son Nhut Air Base where he was stationed near Saigon, as well as photographs taken of street scenes, people, temples, the zoo, the riverfront, and other sights of Saigon (now also known as Ho Chi Minh City). There are five photographs taken by an unknown GI of performers, including Bob Hope, entertaining the troops at Tan Son Nhut Air Base. There are also a few photographs of Mark Kurtz at Air Force bases in the United States (1963–1966) and some of him in Vietnam.

Other materials include the Air Force Commendation Medal awarded to Mark A. Kurtz for meritorious service as Photo Interpreter, 13th Reconnaissance Technical Squadron, and its accompanying citation; manuscripts written by him including biographical information and an essay about his time in Vietnam as well as some notes about his photographs; a couple of letters he wrote to his family while he was in the Air Force; photocopies of newspaper clippings about his career moves and other accomplishments; and a small paperback Vietnamese phrase book for speakers of English.

The collection includes two series:

Series 1, Manuscripts, Printed Materials, and Artifact: This is composed Mark Kurtz's biographical essay, his account of his time in Vietnam, and notes about his photographs; correspondence; photocopies of newspaper clippings; the Air Force Commendation Medal and citation; and the Vietnamese phrase book.

Series 2, Photographs: This includes prints of various sizes (mostly black-and-white), contact sheets, black-and-white negatives, color slides and transparencies, color negatives, and one Polaroid print.
