HISTORICAL SKETCH

On 17 March 2007, a group of scouts and adults met at Marquette Manor and interviewed fifteen residents of the retirement community. The interviews were conducted for Skye Wallin's Eagle Scout project. Wallin trained the volunteer interviewers in how to conduct the interviews and provided the necessary materials. The volunteer interviewers then created transcriptions for their interviews. The transcriptions were checked by Wallin for punctuation, spelling, and format.
