BIOGRAPHICAL SKETCH

In 1839 Samuel Martindale, Jr. (1815–1867), moved his family from Miami County, Ohio to 240 acres of land in Warren County Indiana, near Pine Village. He and his wife Elizabeth produced eleven children. After Samuel's death, the farm was managed by his sons, Henry and John. Two of Martindale's other sons, William and Eudorus, also received tracts of land and became successful farmers and stock breeders.

SCOPE AND CONTENT NOTE

The collection mainly consists of financial records of the operating of Martindale land and business ventures in Warren County, Indiana, 1844–1899. Included are receipts, tax records, account books, and some correspondence as well as printed materials and documents. Other materials in the collection are a Republican Party Poll Book, April 1874; two postcards of the Pine Village football team, 1907–1908; general documents and printed items, 1862–1871; and documents and printed materials and reunion photographs regarding Claude Martindale's service as an artillery officer in the U. S. Army during World War I, 1917–1948, including a panoramic photograph of the all black 317th Trench Mortar Battalion, 92nd Division taken upon their return home.
