## BIOGRAPHICAL SKETCH

George E. Mullin (1875-1946) was born in Fairfield, Franklin County, Indiana. His father was Mark Mullin (1846-1932), who farmed in Fairfield Township from 1871 to 1908.

George E. Mullin attended Indiana Law School in Indianapolis, and was admitted to the Indiana bar in 1901. He

practiced law for three years in Brookville in partnership with M. P. Hubbard, and then served for four years as postmaster in Brookville. From 1905 to 1915 he resumed his legal practice, combining it with the real estate business. From 1915 to 1925 he was secretary and cashier of the Peoples Trust Company in Brookville. He then returned to his legal practice. He had two sons, George E. Mullin, Jr. (born 1904) and James P. Mullin (born 1907), the donor of this collection.

## SCOPE AND CONTENT

This collection, filling four folders, contains correspondence and legal documents from the period 1902-1926.

In Folder 1 is a 1902 deed of property from Martha and Thomas C. Sheppard to George E. Mullin. Folder 2 contains correspondence of 1924-1925 from Charles L. Henry, Indianapolis, president and receiver of Indianapolis and Cincinnati Traction Company, to George E. Mullin, care Peoples Trust Company in Brookville. A letter of 24 December 1924 encloses a letter to stockholders of the traction company outlining plans for possible extension of the line to Cincinnati. Another of 7 July 1925 deals with obtaining witnesses to an accident on the road.

Folder 3 contains a 1913 lease of land in Fairfield Township from Mark Mullin to Levi Mullin, and a 1926 note for \$134 from Levi Mullin to Mark Mullin. Folder 4 contains two envelopes, one with an engraving of the Claypool Hotel in Indianapolis, the other with notations about promissory notes.
