## **BIOGRAPHICAL SKETCH**

Ogle Sanders (1891–1941) was born in Greenwood, Johnson County, Indiana, to Francis and Sarah Sanders.

Ogle moved to Marion County at an unknown date. He married his first wife, Anna Linton Cunningham, on 21 June 1916.

In 1917, at the time of the draft for World War I, Sanders was working as a motor builder for Premier Motor Company in Indianapolis.

After the war, Sanders returned to Indianapolis, where he continued working in the auto industry as a mechanic and tinner. He was divorced by 1920. However, Sanders married his second wife, Ruby Buzzaird, on 19 April 1923.

By 1930, Sanders and his wife had moved to Alameda, California, where he remained until his death in 1941.

## **SCOPE AND CONTENT NOTE**

This collection contains 3 items pertaining to Ogle Sanders' service in World War I.

The first item is a notice from the Local Board Division No. 1 of Marion County requiring Ogle Sanders to report for a physical examination on 10 August 1917.

The second item is a small photograph album containing 20 photographs taken circa 1917–1918. Most of the photographs are of Ogle Sanders in uniform, including several photographs of Ogle posing with family and/or friends. Album also includes two photographs of an unidentified woman, possibly Sanders' first wife.

The third item is Ogle Sanders' dog tags.
