BIOGRAPHICAL SKETCH

Samuel Marion Van Cleave was a professional photographer, among other occupations, who spent time photographing at Turkey Run in Parke County. It is believed that he was in charge of the campground at Turkey Run before it became a state park in 1916.

Samuel Marion Van Cleave was born on 20 November 1869 in Crawfordsville, Indiana. He was the fifth of seven sons born to Alfred Thomas Van Cleave and Catharine Ann Saylor Van Cleave. His older brothers were William Henry, James, Charles, and George; his younger brothers were Bert and John. Samuel grew up working on a farm in Montgomery County. He attended Central Normal College in nearby Ladoga, Indiana, and then taught school in Montgomery County.

Samuel married Emma Winter in Montgomery County, Indiana, in the summer of 1895. At the time of the 1900 census, they were living in Lebanon, Indiana, where he worked as an advertising agent. Emma died in in 1908.

On 29 July 1909, Samuel married Lottie Armstrong in Dayton, Ohio. She often accompanied him in his work as a traveling advertising salesman, as they visited most of the states in the country. In March 1917, they moved to Marion, in Grant County, Indiana, where they lived for twenty-two years. He worked in the automobile business with his brother, George Van Cleave, until 1925. Samuel then ran for Mayor of Marion, but was defeated by James McConnell, who then appointed him as superintendent of the Marion City Water Department. Samuel held that position for more than thirteen years. He was also a notary public and was the first manager of the automobile license department in Grant County. After retiring from the Water Department in 1939, Samuel worked in the real estate business until December 1947.

Lottie Armstrong was born on 24 April 1876 in Crown City, Ohio, to Charles E. and Emily Thompson Armstrong. She was the second eldest of several children. Lottie's older brother was Wilbert, and her younger siblings included Olia, Henry, Franklin, Ernest, Martha "Mattie" (Dorton), James, Carrie (Faul), and Bertha (Hammer). Her father farmed in Gallia County, Ohio, but by 1890 the family moved, by barge down the Ohio River, to the area of Huntington, West Virginia, to farm there. Sometime between 1900 and 1909, the Armstrong family moved to Dayton, Ohio.

After Samuel retired at the end of 1947, he and Lottie moved to Dayton, Ohio, where she could have easier access to needed medical care and be near her siblings. The 1950 census shows Samuel and Lottie living with her brothers Henry, Ernest, and James in Montgomery County, Ohio. Lottie died on 28 November 1952, and Samuel died on 16 December 1954, both in Dayton. They were both buried in Grant Memorial Park cemetery in Marion, Indiana, beside Samuel's brother, George.

George W. Van Cleave was born 21 December 1866. He married Mattie Dell Virts (1868–1913) in 1887. At the time of the 1900 census, George and Mattie and their children Ethel and Leo were living in Crawfordsville, where George worked as a policeman. In 1910 the couple lived with their daughter Ethel and her husband in Frankfort, Clinton County, where George worked as an auctioneer. After Mattie's death, George married Dortha Ethel Curry (1884–1971), who was called by her middle name, in 1914. In 1920, George and Ethel shared a house with his brother Samuel and his wife Lottie in Marion, where George and Samuel

worked together selling automobiles. At the time of the 1930 census, George was again working as an auctioneer. Samuel and Lottie were no longer living with him, but his father-in-law was. George died on 16 October 1930.

Martha Ann "Mattie" Armstrong was born in Ohio, on 17 March 1886. She married Carl John Dorton (1880–1960), sometime between August 1912 and August 1913. Their children included Robert Henry (1913–1986), twins Alene Margaret (Worstell) (1915–1987) and Marion Alma (Denney) (1915–2014), and Delores I (Wolfe) (1922–2001). Carl worked in the metal-forging industry. The family lived in Marion, Indiana, in 1920. By 1930 they had moved to Muncie, and by 1940 to Union Township in Delaware County, Indiana. Mattie died on 19 June 1947 in Delaware County.

Carrie Sarah Armstrong was born on 3 March 1890 in West Virginia. At the time of the 1910 census, she was working as a clerk in a dry goods business in Dayton, Ohio. She married Carl Henry Faul (1889–1968) in October 1913. They had a daughter, Martha Jayne (Moore) (1914–1989). The family lived in Dayton, where Carl worked first as a toolmaker and later for a refrigerator manufacturer. Carrie died on 27 January 1968.

Bertha Armstrong was born on 2 February 1895 in West Virginia. Her first husband, Emerson Glotfelter, was a policeman in Dayton, Ohio; he died of pneumonia at the age of 24 in December 1918. They had a daughter, Mary Emerson Glotfelter (1919–2004). Around 1926, Bertha married Earl Allison Hammer (1891–1955). Their son, Earl A. Hammer, Jr. (1927–1953) was born in Ohio. In 1930 the family lived in West Virginia, where Earl Sr. worked as an airplane inspector. In 1940 they lived in Maryland, where he worked as an aircraft inspector for the U.S. Army Corps. In 1950, Earl Sr. and Bertha lived in Wichita, Kansas, where he was the proprietor of a service garage. It appears that within a few years after that, they had moved to Birmingham, Alabama. Earl Jr. died in Birmingham on 22 September 1953. Earl Sr. died in Birmingham on 4 June 1955, and was buried in Dayton, Ohio. Bertha died on 11 October 1978 in Ohio.

SCOPE AND CONTENT NOTE

This collection includes photographs and some manuscript materials pertaining to Samuel Marion Van Cleave, his wife Lottie Armstrong Van Cleave, and some of their relatives. Most of the photographs were taken by Samuel Van Cleave at the site of Turkey Run State Park in Parke County and are in the format of real photo postcards. Some of the photographs were taken at Turkey Run before it became a state park. These photographs show family members and others at campsites as well as scenic areas. A small number of these postcards were sent through the mail; six were sent to Mattie Armstrong Dorton – four from her sister Lottie and two from her sister Bertha. Some were postmarked from Bloomingdale and some from Marshall, both in Parke County near Turkey Run. Additional photographs include formal portraits of Samuel Van Cleave and of his brother George with his second wife, Ethel.

There is also a folder of manuscript materials including some Armstrong and Dorton family history, a short autobiography of Samuel Van Cleave, a short biography of Lottie Armstrong Van Cleave, and several poems written by Samuel Marion Van Cleave.
