#### **BIOGRAPHICAL SKETCHES**

Solomon Meredith (1810-1875) was born in Guilford County, North Carolina, to Quaker parents. In 1829 he moved to Wayne County, Indiana, where he did various jobs including farming and shop keeping. He eventually moved to Cambridge City where he owned a large farm and became a noted cattle and other live-stock breeder. In 1836 he married Anna Hannah and they had four children, three sons and a daughter who died in infancy.

In addition to his business interests, Meredith was engaged in politics and was a ardent supporter of the Whig and later Republican parties. In 1834 he was elected as Wayne County Sheriff, and from 1846-1849 elected to the Indiana House of Representatives from 1846-1849, U.S. Marshall for Indiana, 1849-1853, and state representative again in 1855. In July, 1861, he was named colonel of the newly formed 19<sup>th</sup> Indiana Regiment which was sent to Washington, D.C. where it became part of the Iron Brigade. In October, 1862, he was promoted to Brigadier General and commanded the regiment at the Battle of Gettysburg. He was severely wounded during the battle on 1 July 1863 being struck in the head by shrapnel. The blow also killed his horse which fell on him breaking several ribs and injuring his leg. Meredith spent the remainder of the war doing administrative work at ports along the Mississippi River at Cairo, Illinois, and Paducah, Kentucky. In 1864 he ran unsuccessfully for the U.S. House of Representatives against. The two candidates feuded to the point where Meredith beat Julian senseless with a whip although no charges were filed.

Meredith returned to his farm after the war but never completely recovered from his war wounds. He served briefly as county tax assessor from 1866-1867, and surveyor general for Montana Territory from 1867-1869 before returning to his Cambridge City farm where he died in 1875.

Other family members prominent in the collection are Meredith's son, Henry C. and his wife Virginia Claypool Meredith. Henry C. Meredith (1843-1882) assumed operations of the family farm and livestock business following the death of his father. He was also editor of the Cambridge City *Tribune* (1869-1872), a member of the Indiana House of Representatives (1881), and president of the state board of agriculture (1882). Virginia C. Meredith (1848-1936) married Henry C. Meredith in April, 1870, and resided with her husband on the family farm near Cambridge City. She assumed household operations when her mother-in-law died in 1871. She became involved in the raising of livestock while her husband served in the state legislature and assumed operations of the farm when he died the following year and evolved into the foremost female authority on agriculture. She was also President of the Board of Women Managers for 1893 World Columbian Exposition in Chicago. Another son, Samuel H. Meredith, served as a lieutenant with his father in the 19<sup>th</sup> Indiana. He was wounded at the Battle of Gainesville in 1862 and never fully recovered, dying at home two years later

### **SCOPE AND CONTENT NOTE**

This collection is comprised of the papers of Solomon Meredith and his family members. Included are letters to Solomon Meredith regarding the appointment of deputies while he served as U. S. Marshall, 1849-1853; official and personal papers relating to his Civil War service including correspondence, his diary from 1862, letters to his wife while commanding the 19<sup>th</sup> Indiana in Virginia, 1862-1863, and correspondence while commanding forces in Western Kentucky, 1864-1865. In addition, there is a folder of materials relating to his run for the U. S. House of Representatives, 1864. Other Solomon Meredith material include his diaries, 1857, 1858, 1872, primarily dealing with farm, and his legal and financial papers dealing with farming, canals, and railroads, 1847-1860.

Also included are the diaries of his son, Henry C. Meredith, 1863, 1873-1881, primarily centering on farm accounts; diaries and related materials of his wife, Virginia Claypool Meredith, pertaining to her role with the Bureau of Lady Managers for the Columbian Exposition in Chicago, 1890-1898; and the muster in and out rolls for Lieutenant Samuel H. Meredith, 1861, 1864.
