BIOGRAPHICAL SKETCH

Steven Leslie Tuchman was born on September 3, 1946, the first child of Fred and Lillian Tuchman, in Indianapolis, Indiana. Tuchman grew up on the northside of Indianapolis with his two younger siblings Linda and Robert, and graduated from North Central High School in 1964. He left Indianapolis for Bloomington to study at Indiana University, graduating with a degree in history. Tuchman went on to earn his Doctor of Jurisprudence, also from Indiana University. During his legal studies, Tuchman was able to spend time in London, completing a certificate in International Law. While abroad, Tuchman befriended some Danish students. His relationship with them, especially with Claus Frederiksen and his family, led Tuchman to leave the United States for Copenhagen, Denmark, after sitting for the bar examination. Tuchman spent over two years in Denmark, becoming fluent in Danish and working first as an English instructor and later for Danske Bank in the legal department. Years later, Tuchman maintained relationships with his Danish friends and contacts, and was eventually named as Honorary Consul to Denmark by Queen Margrethe II in 2004.

Tuchman returned to Indianapolis in 1973, and shortly thereafter began working for Melvin Simon & Associates as a real estate counsel, where he remained for eight years before entering into private legal practice. In 1990, Tuchman signed on at Lewis & Kappes, where he specialized in immigration law. Tuchman has been named to the *Super Lawyers* publication for many years because of his skills and authority in immigration law. Tuchman has been involved with the American Immigration Lawyers Association and the Indianapolis Bar Association. Aside from his legal practice, Tuchman has also taught real estate law classes at the Indiana University School of Business in Indianapolis, and has also owned and managed properties around Indianapolis, specifically the McQuat building on East Washington Street.

Aside from his professional activities, Tuchman has been heavily involved with the Arts scene in Indianapolis since the late 1970s. Tuchman was an early member of the Dance Kaleidoscope board, and also worked on the International Violin Competition of Indianapolis. Throughout the 1980s and early 1990s, Tuchman could be heard on the radio and later seen on television serving as an Arts critic for public radio and WTHR. Tuchman also had reviews published in the Indianapolis *Times*, the *New Times*, and was a Midwestern correspondent for *Variety*. Over this period of time, Tuchman viewed hundreds of performances all over the city. Tuchman's dedication to the Arts scene in Indianapolis culminated in an appointment by Governor Frank O'Bannon to the Indiana Arts Commission, where he served from 2000-07.

Tuchman has also been active in politics and philanthropic organizations. Tuchman served as President of the Board of Directors of Planned Parenthood of Central Indiana in the early 1990s. He has also been involved with the Downtown Kiwanis, the Rotary Club, and the Indianapolis Hebrew Congregation. He has been a supporter of the Indiana University Student Foundation and Lambda Legal. Most recently, Tuchman and his partner of 28

years, Reed Bobrick, have established a scholarship at the IU McKinney School of Law for a self-identified gay male student.

SCOPE AND CONTENT NOTE

This collection is representative of the personal, professional, and civic life of Steven Tuchman. The collection is divided into four series, and the folders in each series are arranged in chronological order.

Series 1 contains the personal papers of Steven Tuchman. The majority of this correspondence contains personal correspondence, and is mostly letters and cards received by Tuchman from friends and family. There are also some mementos, such as maps, guidebooks and diaries from Tuchman's travels abroad as a young man, which seems to have been a very meaningful time in his life in terms of self-discovery.

Series 2 contains documents related to Tuchman's professional life as a lawyer, teacher and real estate owner. Included in this series are documents from Tuchman's service on Indianapolis Bar Association committees, correspondence generated due to Tuchman's ownership of the McQuat building, as well as syllabi and exam questions Tuchman used when he was teaching real estate law.

Series 3 documents Tuchman's civic life, his involvement with the arts and civic organizations in Indianapolis. The majority of these items are scripts, copy and programs from many of the performances Tuchman reviewed over the years. Also documented, among other things, is his involvement with Planned Parenthood, the Kiwanis, and his Honorary Consul appointment.

Series 4 contains photographs and slides. The majority of photographs are snapshots of gatherings with the Tuchman family and Tuchman's friends over the years. Beginning in the 1990s, many of the photographs document gatherings and guests who stayed with Tuchman and Reed Bobrick at their home on Lake Syracuse. There are also a few photographs with members of the extended Tuchman and Alper (Lillian Tuchman's side) families from the 1940s and 1950s. The boxes of slides document a trip the Tuchman family took to Europe in 1968, as well as Tuchman's travels while studying in London and living in Denmark. Also included are some slides from a trip that Fred and Lillian Tuchman took to Israel in 1975.
