HISTORICAL SKETCH

Scottish Rite Freemasonry, also known as 32nd Degree Freemasonry, is a fraternity of men who, according to the organization's website, work to be guided by six core values: reverence for God, integrity, devotion to country, justice, tolerance, and service to humanity. The Supreme Council of the Ancient Accepted Scottish Rite is the governing body of 32nd Degree Scottish Rite Freemasonry. The Supreme Council meets on an annual basis, at which time the business of the fraternity is done and the 33rd degree is conferred on those who have been elected to receive this honor.

The Scottish Rite appears to have started in Paris, France, around 1758. The Scottish Rite was established in the United States in 1801 in Charleston, South Carolina. In the United States, the Scottish Rite is organized into two regional jurisdictions: the Southern Jurisdiction and the Northern Masonic Jurisdiction.
