SCOPE AND CONTENT NOTE

This collection is made up of five manuscript boxes of materials relating to attorney Tom C. Huston's involvement with the historic preservation movement in Indianapolis in the late 20th century. The folders are arranged in chronological order.

The majority of the papers contain correspondence (Preservation Task Force), legal documents, and architectural notes and renderings that relate to the construction of Circle Centre Mall downtown Indianapolis. There are a few items—reports, clippings, correspondence and publications that have to do with other historic preservation projects in Indianapolis, such as Lockerbie and Lockefield Gardens.
